PURPOSE OF REPORT

The report consolidates the effect of the Council's approved budget and precepting authority requirements in order to establish the necessary Council Tax levels to apply in the Borough of Gosport for 2014/15.

1.0 BACKGROUND

1.1 Following approval of the Council's budget for 2014/15 at Council on 12 February 2014 and having received the precepts from Hampshire County Council, the Hampshire Fire and Rescue Authority and the Police and Crime Commissioners for Hampshire, the following table now summarises the Borough's overall Council Tax requirements for 2014/15

4.0 RECOMMENDATIONS

- 4.1 That it be noted that the Borough Treasurer determined the Council's Tax Base on 15 January 2014 in the amount of 24,794.1 as its Council Tax Base for the year 2014/15 (Item T in the formula in Section 31B of the Local Government Finance Act 1992, as amended (the "Act")).

- 4.2 By virtue of the budget approved by Council on the 12 February 2014 the following amounts be now calculated by the Council for the year 2014/15 in accordance with Sections 31 to 36 of the Act:-

- (a) £55,781,908 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act.
- (b) £50,753,417 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
- (c) £5,028,491 being the amount by which the aggregate at 4.2(a) above exceeds the aggregate at 4.2(b) above, calculated by the Council, in accordance with Section 31A(4) of the Act, as its Council Tax Requirement for the year. (Item R in the formula in Section 31B of the Act).

(d) £202.81 being the amount at 4.2(c) above (Item R) divided by Item T (the amount at 4.1 above, calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year.
